- 8.3(d).1 Cllr Bunclark presented the report, a copy of which is attached to these minutes.
- 8.3(d).2 There was considerable debate and Mr Green clarified several points and answered the many questions put by Members.
- 8.3(d).3 RESOLVED that, although the Council acknowledges the need for the redevelopment of this site, it cannot support this application in its current form for the following reasons:
 - 1. The access to the proposed properties is not good, the number of vehicles for tenants plus deliveries and visitors raises safety concerns for this quiet family-focused cul-de-sac. (The Vineyard)
 - 2. The size of the plot itself is not large, the volume of homes proposed constitutes over-development of the land, with the homes 'shoe-horned' into the plot and consequently little room provided for vehicles parking, turning or simply off-loading. The courtyard created by the proposal would in effect create a hazard for residents entering or leaving their homes. Having gardens separate from the properties is undesirable given that they are intended to be for families.
 - 3. The terrace row is proposed to sit right behind the rear of the Seven Stars and alongside the boundary of the playing field. Whilst the pub is closed there will be no noise, but would residents be happy to have a busy/thriving village pub with all the associated noise? They will also experience noise from the adjacent children's play area.
